#### EXCHANGE AND THE RIGHT TO WITHDRAWAL

We reserve the right to demand compensation for items returned in poor condition due to additional usage. The costs of return will borne by customer. Refunds are acceptable only if Artsound and Lights co is unable to proceed the order and it concerns payment methods 3.B and 3.C.

### 2. DELIVERY/SHIPPING INFORMATION

The shipping costs are calculated automatically through our online store. Please be aware that if you are making an advance payment (money bank transfer), the delivery period will only begin one day after the transfer has been made (once the bank has received the payment order). There is no minimum order value.

All prices indicated in the ArtSound & Lights Online Shop include the currently valid Greek VAT rate. You may choose to show prices including VAT or excluding VAT by clicking "Inc / Ex. VAT" button. You may also choose to view the product in Euros, Dollars or GBP.

You can choose whether you wish to pay the merchandise by Advance Payment – Money Bank Transfer, Credit Card via PayPal, Credit Card via Piraeus Bank (Winbank), Credit Card via Eurobank (up to 3 installations).

# 8. LEGAL INSTRUCTIONS ON WITHDRAWAL

#### 8.1. Right of withdrawal

You have the right to withdraw from this contract within 14 days without giving any reason. The withdrawal period will expire after 14 days from the day on which you acquire, or a third party other than the carrier and indicated by you acquires, physical possession of the goods, in the case of partial deliveries, the last of the goods.

To exercise the right to withdraw, you must inform us of your decision to withdraw from this contract by an unequivocal statement (e.g. a letter sent by post, fax or e-mail). You may use the attached model withdrawal form for this purpose, but it is not obligatory.

# 8.2. Effects of withdrawal

If you withdraw from this contract, we shall reimburse to you all payments received from you, including the costs of delivery (The costs of return will borne by customer), without undue delay and in any event not later than 14 days from the day on which we are informed about your decision to withdraw from this contract. We will carry out such reimbursement using the same means of payment as you used for the initial transaction, unless you have expressly agreed otherwise; in any event, you will not incur any fees as a result of such reimbursement. We withhold reimbursement until we have received the goods back or you have supplied evidence of having sent back the goods, whichever is the earliest.

The deadline is met if you send back the goods before the period of 14 days has expired. You are only liable for any diminished value of the goods resulting from the handling other than what is necessary to establish the nature, characteristics and functioning of the goods.
